Call to order Pledge of Allegiance

Approval of agenda Motion by Supervisor Merrill seconded by Supervisor Popelka, to approve. Motion carried

 Discussion/Possible Action to Approve Operator Licenses for Bailey Weingarten, Lisa Brauer, Becky Brauer, Sheila Pecsenye, Carlie Calkins, Arin Davis, Kristi Friermood, Sheila Applen
 Motion by Supervisor Popelka seconded by Supervisor Hambrecht, to approve the operators' licenses above.

2. Update - Telemark Golf Course, Liquor License

Clerk Rauch consulted the Wisconsin Towns Association Attorneys with regards to sending the letter out to Telemark Enterprises, at this point the town has still not heard anything from Telemark Enterprises.

3. Discussion/ Possible Action Regarding Town Hall Road/ possible Abandoned Roads

Motion by Supervisor Merrill seconded by Supervisor Weber, Supervisor Popelka abstains from any voting, Supervisor Merrill added that this existing road is a dead end and let the Lutheran Church and the adjoining landowners create an easement for the access to the property. Tom Frels is representing the Lutheran church, and has explained that the church has owned and maintained the parking lot for a period of 40 yrs. Foreman Swanson has noted that he should go to Washburn to research the Road. Jack Radecki added that the town had in the past tried investigating the abandonment of Town Hall Rd. Jack Added that it is the Planning Commission who is responsible to investigate and/or plan roads. Supervisor Weber offered to look into the deed with regards to the how and what the deed may say or include. Supervisor Weber will work with Foreman Swanson, Motion by Supervisor Hambrecht seconded by Supervisor Merrill to table the town hall road abandonment until we are able

4. Discussion/Possible Action Choosing the Town Attorney

Clerk Rauch had contacted 3 attorney's, Clerk Rauch read their credentials and abilities as well as fees. Motion by Supervisor Weber to hire Clark and Clark as the Town's Attorney's, no second, motion failed. Motion by Supervisor Hambrecht seconded by Supervisor Popelka to hire Weld Riley as the Town's Attorney. Voting 3 ayes-Supervisor Merrill, Supervisor Hambrecht, Supervisor Popelka - 1 Ney Supervisor Weber. Motion carried.

5. Discussion / Possible Action to Address Municipal Parking Lot Signage and Brakken St. Walking/Hiking Trail. Ron Bergin spoke regarding CAMBA signs. Ron is asking to put a larger sign at the municipal parking lot for the trailhead, and a smaller sign on Randysek rd. directing people into the lot as well. Foreman Swanson, asked if the larger sign on Randysek Rd/Reynolds Rd. by the Brickhouse and the smaller still directing the people into the lot. Ron will be happy to work with Jason. Brakken Rd/Hiking walking trail. Ron has been working on this walking trail since 2018 this is a mixed walking trail along the Railroad grade, this project is still ongoing with the parks service, this trail is flat level ground that is easier for a more intermediate group. Supervisor Popelka wanted to know why the Town is not pursuing the trail as a multi -use trail. Motion on Parking Lot signage by Supervisor Hambrecht, Seconded by Supervisor Merrill. Motion carried.

6. Discussion / Possible Action Street/Line painting

Foreman Swanson explained the time constraints, parking space markings, line painting, etc. We received a quote from a firm for \$4,870. To paint lines on CTY M by the Chamber, Real estate office, Velo's, Brickhouse Kavanaugh Rd. Etc. Motion by Supervisor Weber seconded by Supervisor Hambrecht, to Hire out the painting. Motion Carried.

7. Discussion/ Possible Action Great Divide Riders ATV Club wishes to Construct a Kiosk at the Municipal Park lot. Great Divide Riders ATV Club came to Supervisor Merrill and requested that the club construct a 4ft x 8ft kiosk for the purpose of ATV information on a section of 4x4 ft, have 2x4 ft available for Town information and 2x4 ft for anyone's use. Discussion regarding installing a bulletin board on the south side of the municipal bathrooms, where there is lighting and have a hanging organizer for trail maps mounted below for all users, CAMBA, Skiers, ATV, Community, etc. to place their maps. Motion by Supervisor Popelka seconded by Supervisor Hambrecht to have the Cable Hwy dept install the 2 bulletin boards on the south wall. Motion Carried.

8. Discussion/Possible Action Regarding the Cable Chamber Sign.

Supervisor Merrill explained that this issue was brought up at the Plan Commission meeting the night before and that this sign was a static L.E.D. sign for information Motion by Supervisor Merrill seconded by Supervisor Weber to allow such a sign in the Town of Cable. Motion carried.

9. Discussion/Possible Action Regarding the Cable Recreational Park

The Park is becoming very popular, the tennis courts have been used a lot for pickle ball. Chairman Haag had reached out to a firm he has worked with in the past building playgrounds to get ideas. Supervisor Weber and Supervisor Popelka feel we should have a cohesive design for the playground/park. Consensus is to set up a parks committee, have the clerk or website designer create a survey to get ideas from the community. Motion by Supervisor Popelka seconded by Supervisor Weber to start the planning of the park with a survey. Motion Carried.

10. Discussion/Possible Action Moving the Camping Fee Post at the Park to a MORE Visible Area

It has been noted to move the fee tube and kiosk to the main entrance by the Depot where it would be more visible to everyone. Motion by Supervisor Weber seconded by Supervisor Hambrecht, Motion carried

11. Discussion/ Possible Action WI UDC Inspector for Cable

Chairman Haag, has been informed that our current UDC inspector is less than professional, Chair Haag has reached out to Steve Boss Inspections, Steve has emailed a contract to Chairman Haag for review. Chairman Haag will clarify with Steve Boss as far as him reporting to the DSPS. Motion by Supervisor Weber seconded by Supervisor Hambrecht, to Designate Steve Boss as the UDC inspector for the Town of Cable Effective July 7, 2021. Motion Carried.
