It was reported that the Commission received an email from Deputy Clerk Tammy Rasmussen on how to proceed with paying Commission employees through Cable.

MOTION by Commissioner Rasmussen, seconded by Commissioner Nelson to route all payroll for Commission employees through the Town of Cable. MOTION carried.

Bayfield County has confirmed that annually it gives an allotment of \$10,000 to the Ashland Airport. The Commission discussed the fact that the Ashland Airport is not in Bayfield County, and the Cable Union Airport should receive at least as much as Ashland. The County has indicated that any increase in allotment requests will be met with the need for good reason.

The Fat Tire event is September 13 and 14, 2019. As agreed with Fat Tire officials, Treasurer Dick Fredericks will send an invoice for \$500 per day for parking allowed on airport property.

Manager's Report

The fuel terminal is now online. The entire installation cost \$1260, including electric and the line Norvado installed. There is a warranty for two years. Tech support is \$945 per year, but there is no telephone bill.

FAA will conduct its next snapshot of the airport in December 2019, for Fiscal Year 2021-2022. This is when our now 12 based planes will show on their records, qualifying the airport for federal funding in 2020.

Birkie Representative Kristi Maki will attend the Airport Commission meeting in August to discuss parking for Birkie events.

Tim DeChant has been contracted to set the rod in concrete for the hangar door.

The Fly-In Hamburger Night will be Tuesday, July 16, 2019, from 5:00 to 7:00 p.m. There is also a flyer for the free youth rides for August 3, 2019, that is also being advertised by the Cable Area Chamber of Commerce.
