TOWN OF CABLE DOG ORDINANCE

The Town Board of the Town of Cable, County of Bayfield, do ordain as follows:

- (1) It shall be unlawful for any person owning, keeping or harboring any dog, to permit such dog to run at large within the limits of the Town of Cable, at any time.
- (2) All dogs shall be licensed, cared for, maintained and handled in a humane and sanitary manner in such a way as to prevent noises, barking, fighting, yelping, etc. No person shall keep or harbor within the Town of Cable any dog which by loud, frequent or habitual barking or howling, shall cause serious annoyance to area residents, or otherwise disturbing the peace and quiet of the area.
- (3) No dog shall be abandoned or turned loose by its owner or keeper.
- (4) Any person who shall violate any of the provisions of this ordinance or any regulation or order made therein shall upon conviction, forfeit not less than \$25.00 nor more than \$100.00 for the first offense, and not less than \$50.00 nor more than \$200.00 for subsequent offenses; and in default of said forfeiture and costs imposed, shall be committed to the County jail of Bayfield County for a term not to exceed fifteen days.
- (5) The enforcement of this ordinance shall be carried out by the Town of Cable Constable. If the identity and ownership of the offending dog can be readily ascertained, the Constable may forthwith advise such owner of the dog's transgressions. This shall not limit the authority of the Constable to prosecute such owner as herein provided.
- (6) It is the intention of this ordinance to protect the citizens from the reavages and damages caused by dogs, particularly those owned by people who fail to respect the rights of others.
- (7) This ordinance shall be in force and take effect from and after passage and publication.

ORDINANCE AMENDING THE TOWN OF CABLE DOG ORDINANCE

11

The Town Board of the Town of Cable, meeting in regular session this 8th day of December, 1993, does ordain as follows:

whereas, the Town has a dog ordinance in effect entitled Dog Ordinance No. 11 in which, pursuant to paragraph 4 of said ordinance, the Town Board is desirous of amending the terms thereof, to facilitate the recapture of expenses incurred by the Town in enforcing said ordinance.

THEREFORE BE IT ORDAINED that paragraph 4 of the Dog Ordinance of the Town of Cable shall be amended as follows:

(4) Any dog in violation of the provisions of this ordinance or any regulations or orders made therein may be picked up by the Constable and housed at a location designated by the Town Board for up to seven days with a charge accumulating to the owner of said dog of \$12.00 per day. There is also imposed upon the owner a \$5.00 pick-up charge. Said charges shall be paid to the Town prior to the release of the dog to the owner. After seven days, if the dog has not been recovered by the respective owner, the Town may turn the dog over to the Bayfield County Humane Officer under the authority of the Bayfield County Sheriff and the Bayfield County Ordinance No. 12.04.

IT IS FURTHER ORDAINED THAT: All other terms and regulations Ordinance No. 11 as adopted July 6, 1987 shall remain in full force and effect.
