

ORDINANCE NO. 5-A

An Ordinance adopting a Municipal Traffic Code, Town of Cable

Section 1. State Traffic Laws Adopted.

The statutory provisions describing and defining regulations with respect to vehicles and traffic in the following enumerated sections and chapters of the Wisconsin Statutes, exclusive of any provisions therein relating to the penalties to be imposed or the punishment for violation of said statutes, are hereby adopted and by reference made a part of this ordinance as if fully set forth herein. Any act required to be performed or prohibited by any statute incorporated herein by reference is required or prohibited by this ordinance:

- 340.01 and 343.01 (Words and phrases defined)
- 342.31 (2) (Report of stolen or abandoned vehicles)
- 342.40 (Vehicle abandonment)
- 343.18 (License to be carried)
- 343.22 (Change of address or name)
- 343.34 (Surrender of license)
- 343.43 (Unlawful practices relative to licenses)
- 941.01 (1) (Reckless driving off highways)
- 947.045 (Drinking in motor vehicles on highways)

Chapters:

- 346 (Rules of the Road) Except s. 346.64
- 347 (Equipment of Vehicles)

Section 2. Speed Limits.

Speed restrictions within the Town of Cable shall be as set forth in Sec. 346.57 Wis. Stats.

Section 3. Snowmobiles.

State Snowmobile Laws Adopted. Except as otherwise specifically provided in this ordinance, the statutory provisions describing

the defining regulations with respect to snowmobiles in the following enumerated section of the Wisconsin Statutes are hereby adopted by reference and made part of this ordinance as if fully set forth herein. Acts required to be performed or prohibited by such statutes are required or prohibited by this ordinance:

- 350.01 (Definitions)
- 350.02 (Operation of Snowmobiles on or in the Vicinity of a Highway)
- 350.03 (Right of Way)
- 350.04 (Snowmobile Races, Derbies and Routes)
- 350.045 (Public Utility Exemption)
- 350.05 (Persons under 12 Operating a Snowmobile)
- 350.06 (Firearms and Bows)
- 350.07 (Driving Animals)
- 350.08 (Owner Permitting Operation)
- 350.09 (Head Lamps, Tail Lamps, and Brakes)
- 350.10 (Miscellaneous Provisions for Snowmobile Operation)
- 350.12 (Registration of Snowmobiles)
- 350.15 (Accidents and Accident Reports)

Section 4. Enforcement.

Enforcement of this ordinance shall be governed by the applicable provisions of Chapter 345 Wisconsin Statutes.

Section 5. Penalty.

Any person who shall violate any of the provisions of this ordinance shall, upon conviction thereof, be subject to a forfeiture of not less than \$5.00 nor more than \$250.00, provided that the maximum shall not exceed the maximum for the same offense under State law and in default of payment of such forfeiture and costs of prosecution, shall be imprisoned in the County Jail until said forfeiture and costs are paid, but not exceeding 90 days.

Section 6. All ordinances or parts or ordinances contravening the provisions of this ordinance are hereby repealed.

Section 7. This ordinance shall take effect and be in force from and after its passage and publication or posting.
