COVID-19 Update Confirmed in Bayfield County

Bayfield County—The Bayfield County Health Department announced today that there is I new confirmed case in Bayfield County, Wisconsin. This is the first case detected in Bayfield County. This individual recently traveled where community spread of COVID-19 is occurring, and developed symptoms shortly afterwards. Self-quarantine procedures have been reviewed with this individual.

Bayfield County Health Department and area health care providers are partnering together to keep track of this outbreak. We are in daily contact with this individual to monitor their symptoms and ensure they are receiving support to be able to isolate at home. We are also working with local, state, and federal partners to deal quickly and effectively when people have symptoms of COVID-19 or have been around people have been infected with the coronavirus.

The Bayfield County Health Department and the Wisconsin Department of Health Services (DHS) responsibilities include:

- Identifying and contacting anyone who has been in close contact with a person who
 has COVID-19. These people are asked to quarantine themselves for 14 days from
 their exposure and will be monitored for fever and respiratory symptoms. People
 with symptoms are tested for COVID-19.
- Performing follow-up testing for individuals who test positive to determine when a person can be released from isolation.
- Providing guidance to clinicians regarding testing.
- Preparing Wisconsin for community spread of COVID-19.
