Whereas, The State of Wisconsin Economic Development Corporation ("WEDC") provides funds through its Idle Sites Grant Program to promote redevelopment of commercial sites in excess of five acres in Designated Rural Areas that have been idle, abandoned or underutilized in order to eliminate blight, foster development and elevate local economies; and

Whereas, The American Birkebeiner Ski Foundation ("ABSF") will soon acquire the former Telemark Resort that adjoins its existing Birkebeiner Trailhead and has identified the WEDC Idle Site Grant as a funding mechanism to accelerate demolition of the current structures and to redevelop of the site as the Mount Telemark Outdoor Recreation Center; and

Whereas, The former Telemark Resort qualifies for an Idle Site Grant to demolish the former lodge because the structure has been vacant since 2013 and has suffered extensive deterioration and the overall property exceeds 700 acres; and

Whereas, After demolition, the ABSF proposes investing \$3.6 million, and with partner investments could be over \$6.0 million, in a phased redevelopment in conjunction with its adjacent facilities as the Mt. Telemark Outdoor Sports Complex to expand the trails and competition venue and to add features for year-round recreational activities; and

Whereas, The new development will attract more participants and visitors to the Cable and the surrounding communities, promote ancillary investment, increase area employment and promote healthy lifestyles; and

Whereas, Because a WEDC Idle Site Grant must flow through the local municipality, the ABSF has requested that the Town of Cable apply on its behalf for a grant up to \$500,000 that would pay the majority of demolition cost for the existing lodge; and

Whereas, The ABSF would grant the Town access to satisfy WEDC access requirements, would prepare all documents for grant application and funding reimbursement, would provide all matching and project funds, would contract and implement the demolition contract, would proceed with project development in accordance with a Development Agreement that will be negotiated with the Town and the ABSF; and

Whereas, The Development Agreement will require upon approval by WEDC that the grant be used only for demolition activities, that a timetable be established for bidding, contracting and demolishing the existing lodge, that all demolition contracts be solely in the name of the ABSF so that the Town is not a party to the contract, that the ABSF would indemnify and hold harmless the Town from any liability for damages as a result of its efforts, and that the ABSF would reimburse the Town for any extraordinary staff expenses; and

Whereas, The Town's participation in the Grant would provide tremendous benefit to the Town through removal of a blighting structure, subsequent private investment with development of the Mount Telemark Outdoor Sports Complex, added tax base, increased tourism expenditures and added employment in the town and surrounding communities; now therefore, be it

Resolved, by the Town of Cable Board, That the Development Agreement with the ABSF that was submitted to the Town Board to submit an Idle Sites Grant application for the former Telemark Resort is approved; and, be it

Further Resolved, That the proper Town officials are authorized to complete negotiations with the ABSF on the Development Agreement and to execute the Agreement for submittal to WEDC for Idle Sites Grant on behalf of the ABSF; and, be it
