





AUTHORIZATION FOR TOWN OFFICERS TO RECEIVE HOURLY WAGE

At the Annual Town Meeting, July 22, 2020, the Town of Cable, Bayfield County, Wisconsin, the eligible electors by a majority vote do hereby resolve and order as follows:
