Resolution approving the purchase of property maintenance equipment by the Cable Union Airport and to allow for contingency financing for the purchase.

Whereas, The Cable Union Airport is owned by the Towns of Cable, Drummond and Namakagon and is operated by the Airport Commission comprised of representatives from each town and

Whereas, Cable Union Airport recently experienced maintenance problems with its mowing equipment and investigated repair and replacement options and costs for these items; and

Whereas, Quotes were obtained for the purchase of a tractor, mower, loader and snow blower and the Airport Commission approved acceptance of a quote in the amount of \$39,300.00 at its Special Meeting held on September 10, 2020 conditioned on the approval by the Town Boards of the three town owners; and

Whereas, The equipment purchase will be paid by funds from the Wisconsin Bureau of Aeronautics (BOA) in the amount of \$25,000.00 and with the balance to be paid by the proceeds from the mortgage fulfillment by the Cable Gun Club that are expected to be received within the next 30 days; and

Whereas, In the event that the Cable Union Airport does not receive the proceeds from the mortgage fulfillment in time to make the equipment purchase, the Airport Commission has requested that each of the three Towns approve contingency funding of approximately \$5,000.00 each in order to complete the equipment purchase in a timely manner; and

Whereas, In the event the Airport Commission receives the mortgage proceeds after the provision of the contingency funding by the towns, the Airport Commission will reimburse the towns for their respective contingency funding; now, therefore, be it

Resolved, By the Town of Cable Board, that Cable Union Airport Commission is authorized to purchase property maintenance equipment in an amount not to exceed \$39,300.00; and, be it

Further Resolved, That the Town Board agrees to provide the Cable Union Airport up to \$5,000.00 for the equipment purchase in the event the Airport Commission has not received the proceeds of the mortgage fulfillment from the Cable Gun Club prior to the equipment purchase; and

Further Resolved, Any contingency funding shall be paid from the General Fund and the reimbursement of such funding shall be returned to that account.
