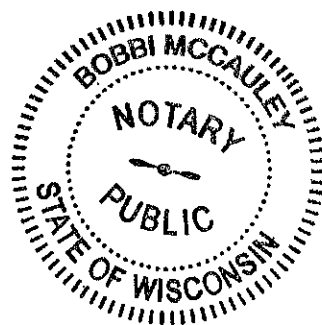

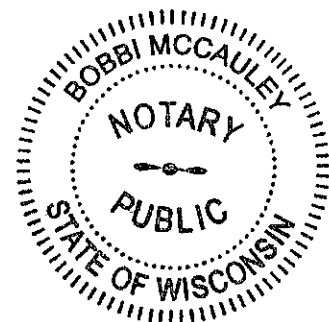


NOTICE SPECIAL TOWN BOARD MEETING
