Having received an application to discontinue a highway by six or more resident freeholders in the Town of Cable, Bayfield County, Wisconsin, to discontinue a highway known as Town Hall Road as described as follows:


In Bayfield County, Wisconsin: Approximately 182'.6" of Town Hall Road Located in Assessor's Plat No. 2, Lot 7, Block 9, located in the SE ¼ of the NW ¼ of Section 18, Township 43 North, Range 7 West, and the remaining Approximate 28'.6" portion of said 211' Town Hall Road that is located in Assessor's Plat No. 2, Lot 8, Block 9, of the SW ¼ of the NE ¼ in Section 18, Township 43 North, Range 7 west, in the Village of Cable, Bayfield County.

A scale map of the land that will be affected by this application is attached.


Notice is hereby given that the Supervisors of the Town of Cable will meet on September 10, 2025, at 6:00 p.m. at the Town of Cable Community Centre, 13660 County Road M, Cable, Wisconsin, 54821, and decide upon the application.

If approved, the Town Board will issue a highway order as per Wis. Stat. §82.12(2) to the Bayfield County Highway Commissioner and Bayfield County Register of Deeds.

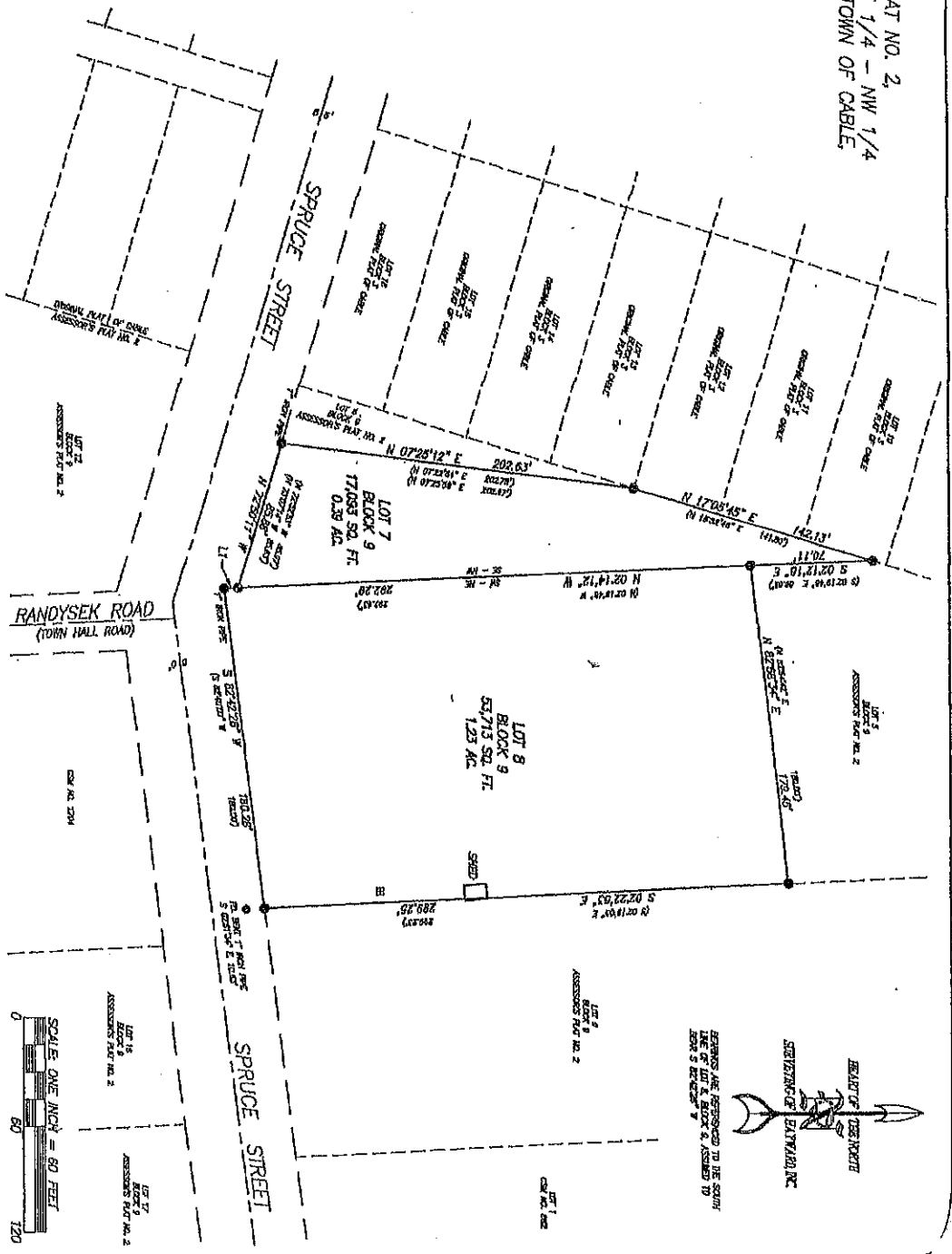
